WAITING / OVERFLOW



Access is allowed from Monday 30/06







PIT GARAGE INFORMATION



As per the regulations of the Imola Circuit, you will have to comply with the following environmental behavioral rules:

The abandonment of waste that does not fall within urban waste collection (such as tyres, batteries, brakes, carpet, containers containing oil/petrol and vehicle parts in general, etc...) is prohibited.

Use the drums available to dispose oil, do not use the drain channels

A financial penalty is applied for the unauthorized abandonment of waste

One person of our staff responsible for the environmental management of the event (recognizable by a yellow jacket and identification card - photo below) will check the methods of waste disposal by the participants.

We believe that this resource we use makes an important contribution to achieving an improvement in waste management by event participants.
